

## ORDINANCE NO. 435, 2ND SERIES

AN ORDINANCE OF THE CITY OF HIBBING, MINNESOTA, AMENDING HIBBING CITY CODE CHAPTER 9 "PARKING REGULATIONS" BY REPLACING SECTION 9.21 ENTITLED 'SNOW EMERGENCY'; AND, BY ADOPTING BY REFERENCE, HIBBING CITY CODE CHAPTER 1 AND SECTION 9.99 WHICH, AMONG OTHER THINGS, CONTAIN PENALTY PROVISIONS.

THE CITY COUNCIL OF HIBBING, MINNESOTA ORDAINS:

Section 1. Section 9.21 entitled "Snow Emergency" of the Hibbing City Code is hereby deleted in its entirety.

Section 2. There shall be added to the Hibbing City Code a new Section 9.21 entitled 'Parking During a Snow Plowing Event' reading as follows:

### **"Sec. 9.21 PARKING DURING A SNOW PLOWING EVENT.**

**Subd. 1. Application.** Notwithstanding any other provisions of the City Code, this Section shall apply to all snowplowing events as defined below.

#### **Subd. 2. Definitions.**

Priority 1 Streets. For purposes of this Section, the following streets are defined as Priority 1 Streets for the purpose of plowing:

##### Priority 1 Streets - Pulled to the Center

1. 1st Avenue from 19th Street to 31st Street
2. 1st Avenue from 37th Street to 42nd Street
3. 2nd Avenue East from 19th Street to 21st Street
4. 3rd Avenue East from 16th Street to 25th Street
5. 4th Avenue East from 19th Street to 21st Street
6. 4th Avenue East from 23rd Street to 24th Street
7. 5th Avenue East from 19th Street to 21st Street
8. 6th Avenue East from 19th Street to South Howard Alley
9. 6th Avenue East from 23rd Street to 24th Street
10. 7th Avenue East from 19th Street to 31st Street
11. 8th Avenue East from North Howard Alley to 21st Street
12. 9th Avenue East from Howard Street to 23rd Street
13. 11th Avenue East Howard Street to 25th Street
14. 19th Street from 1st Avenue to 12th Avenue East
15. Howard Street from 2nd Avenue West to 12th Avenue East

16. 21st Street from 1st Avenue to 9th Avenue East
17. 23rd Street from 2nd Avenue West to Brooklyn Drive
18. Brooklyn Drive from Howard Street to 23rd Street

Priority 1 Streets - Plowed to the Curb

1. 1st Avenue from 31st Street to 37th Street
2. 1st Avenue from 42nd Street Townline Road (CSAH 16)
3. 2nd Avenue West from West Howard Street to 37th Street
4. 3rd Avenue East from 25th Street to 31st Street
5. 3rd Avenue East from 13th Street to 16th Street
6. Brooklyn Drive from 23rd Street to 25th Street
7. 7th Avenue East from 31st Street to 37th Street
8. 9th Avenue West from 37th Street to 47th Street
9. 12th Avenue East from Howard Street to 19th Street
10. 13th Street from 3rd Avenue East to Highway 169
11. 19th Avenue East from 25th Street to 41st Street
12. 25th Street from 5th Avenue West to 19th Avenue East
13. 31st Street from 5th Avenue West to 7th Avenue East
14. 37th Street from 9th Avenue West to Highway 169
15. 37th Street from 19th Avenue East to Highway 169
16. 41st Street from 4th Avenue East to Hwy 169
17. 42nd Street from 9th Avenue West to 1st Avenue
18. 47th Street from 9th Avenue West to 1st Avenue
19. Townline Road (CSAH16) from 1st Avenue to Hwy 73
20. CSAH 63 from 1st Avenue to Kelly Lake
21. Rainey Road from Hwy 169 to Kelly Lake

Snow Plowing Event. A Snow Plowing Event is a time when more than two inches of snow accumulates and snow plowing is occurring immediately after said snow fall. Late Fall and early Spring snowfalls which are deemed to be melting as a result of the temperatures shall not be deemed Snow Plowing Events.

**Subd. 3.** It is unlawful to park or leave standing any motor vehicle on a Priority 1 Street during a Snow Plowing Event."

Section 3. Hibbing City Code Chapter 1 entitled "General Provisions and Definitions Applicable to the Entire City Code Including Penalty for Violation" and Section 9.99 entitled "Violations a Misdemeanor" are hereby adopted in their entirety, by reference, as though repeated verbatim herein.

**Section 4. Posting and Filing.** The Clerk shall see that a copy of this Ordinance is filed in the Clerk's office and in the Hibbing Public Library which the Council hereby designates as locations at which a copy is available for inspection by any person during regular office hours.

**Section 5. Publication and Effective Date.** After adoption, signing and attestation, this Ordinance shall be published once in the official newspaper of the City and shall be in effect on and after the date following such publication.




