**CHAPTER 20**  
**LISTING OF UNCODED ORDINANCES IN EFFECT**

All ordinances described in this Chapter remain in effect after adoption of the City Code. However, they are of a permanent and continuing nature as authority for a certain specific act which has been performed. These ordinances have one, thing in common that generally distinguishes them from other provisions of the City Code - their texts have no continuing reference value. For this reason it appears justified to list and refer to them here only to facilitate finding them in the event this becomes necessary. Listings are grouped according to subject matter, but where only one or two ordinances appear on a single subject, they will be described in a paragraph.

Renumbering and Repeal of Certain Ordinances

Ordinance No. 1, adopted June 27, 1932, providing for the renumbering and identification of all ordinances of the City as revised and codified, and providing for assembling of all such ordinances in a book labeled "Ordinances of the village of Hibbing, 1932".

Ordinance No. 2, adopted June 27, 1932, providing for repeal of all ordinances heretofore enacted which are not named in Ordinance No. 1 or in the book "Ordinances of the Village of Hibbing, 1932".

House Numbering

Ordinance No. 29, adopted February 26, 1907, providing for system of assigning numbers to houses and lots on all streets and avenues.

Public Works Fund

Ordinance No. 132, adopted August 22, 1945, established Public Works Fund in accordance with Chapter 437, Laws of 1943.

Finance Local Improvements

Ordinance No. 193, adopted August 18, 1952, and amended by Ordinance No. 201 adopted August 10, 1953, and Ordinance No. 220 adopted October 30, 1958, providing for financing of local improvements without cost to the City.

Abolishing Office of Constable

Ordinance No. 276, adopted September 8, 1972, abolishing office of Constable.

Memorial Building

Ordinance No. 65, adopted May 20, 1924, calling for election on proposal to build Memorial Building and acquiring site therefor.

Ordinance No. 68, adopted June 10, 1924, calling for erection and equipment of Memorial Building at estimated cost of \$400,000.00.

Ordinance No. 110, adopted January 21, 1936, for the control, supervision, upkeep, maintenance and management of the Hibbing Memorial Building.

Issuance of Bonds

Ordinance No. 58, adopted January 31, 1922, calling for election on a \$2,000,000.00 bond issue to refund the floating indebtedness.

Ordinance No. 66, adopted May 20, 1924, calling for election on issuance of \$400,000.00 worth of bonds for construction of Memorial Building.

Authorize Construction

Ordinance No. 134 adopted June 24, 1941, and Ordinance No. 137 adopted November 18, 1941, authorizes construction, extension and improvement of Hibbing Municipal Airport.

Grant Right-of-Way

Ordinance No. 114 adopted June 7, 1936, granting Duluth, Missabe & Northern Railway Company, a railroad right-of-way over, upon and across First Avenue.

Grant of Authority

Ordinance No. 37, adopted December 3, 1912, granting authority to Standard Oil Company to build and maintain warehouses, tanks, etc.

Execution of Contract

Ordinance No. 56 adopted September 15, 1921, providing for execution of contract between City and Mesaba Railway Company to secure use of certain poles for City lighting system.

Adoption of Codification

Ordinance No. 1, 2nd Series, adopted August 23, 1975, provides for adoption of a codification of ordinances known as the Hibbing City Code.

### Electric Franchise

Ordinance No. 227 (City Code Section 3.50) adopted July 13, 1960, grants an electric franchise to Minnesota Power and Light Company for a period of twenty-five (25) years.

Ordinance No. 163, 2nd Series, adopted August 15, 1988, grants an electric franchise to Minnesota Power and Light Company for a period of ten (10) years.

### Cable TV Franchise

Ordinance No. 151, 2nd Series, adopted April 22, 1987, grants cable communications system franchise to Range Television Cable Co., Inc., for a term of fifteen (15) years.

### Commercial Building Loan Program

Ordinance No. 128, 2nd Series, adopted January 21, 1985, establishes a Commercial Building Loan Program and authorizes the sale of commercial revenue bonds.

Sewer Ordinances

Ordinance No. 122, 2nd Series, adopted October 1, 1984, and published October 25, 1988, regulates the use of public and private sewers and drains, the installation and connection of building sewers and the discharge of waters and wastes into the public sewer system.

Ordinance No. 123, 2nd Series, adopted October 1, 1984, regulates the discharge of waters and wastes into the public waste disposal system and requirements of pretreatment.

Ordinance No. 146A, 2nd Series, adopted October 3, 1988, establishes a sewer service charge system.

Ordinance No. 146-B, 2nd Series, adopted July 15, 1991, amended the sewer service charge set forth in Ordinance No. 146A, 2nd Series.

Ordinance No. 265, 2nd Series, adopted September 18, 2000, adds a paragraph 2.01 n. to Ordinance No. 123, 2nd Series, as follows:

"Any wastewater having a mercury concentration in excess of 1.8 ng/l on a monthly average or in excess of 3.2 ng/l on a daily average."
